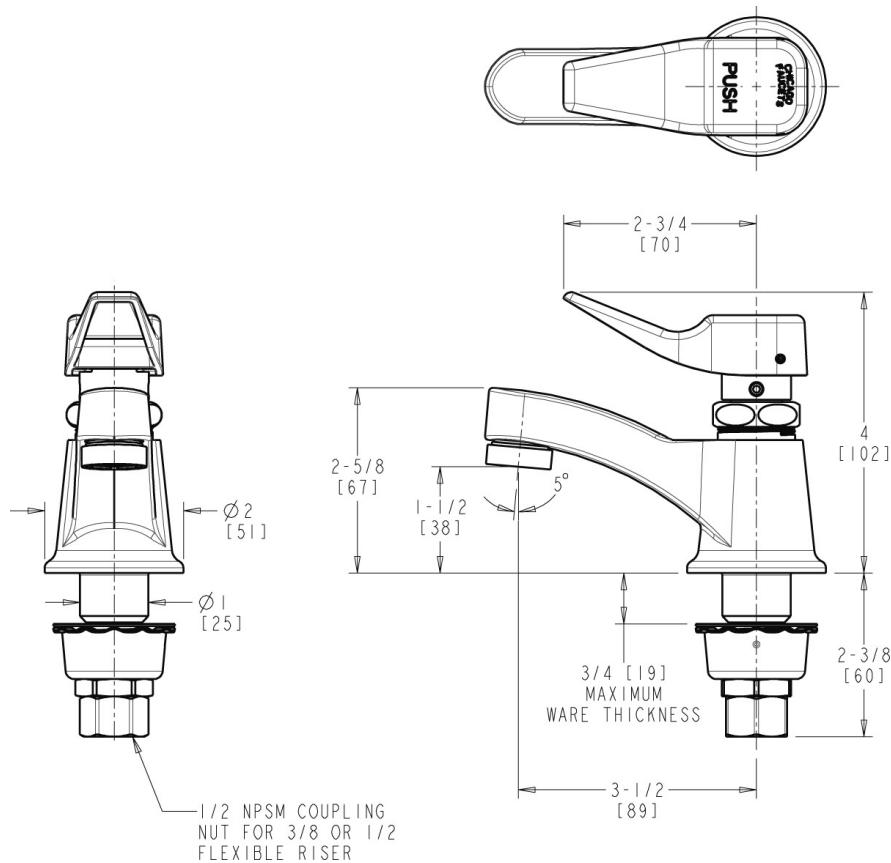

NAIAD rebuildable auto-timed metering cartridge, adjustable run time from 2 to 15 seconds, opens with push, 0.20 max gallon/cycle. 1/2" NPSM supply inlet with coupling nut for 3/8" or 1/2" flexible riser. ECAST® construction with less than 0.25% lead content by weighted average. This product meets ADA ANSI/ICC A117.1 requirements and is tested and certified to industry standards: ASME A112.18.1/CSA B125.1, Certified to NSF/ANSI 61, Section 9, California Health and Safety Code 116875 (AB1953-2006), Vermont Bill S.152, and NSF/ANSI 372 Low Lead Content.



**Operation and Maintenance**
